Forskning

Mitt huvudsakliga expertområde är samspelet mellan **innovation, hållbar utveckling och naturvård, särskilt i utvecklingsländer**. Jag har i synnehet intresserat mig för **omvandlingsprocessen** från ohållbara till hållbara system i miljöer där system är globalt uppkopplade. Mina vägledande frågor syftar till att undersöka vad som möjliggör riktningen och den geografiska skalan på omvandling, och hur hållbarhetsomvandling kan påskyndas. Det senare är av största vikt om vi tänker på hur brådskande de utmaningar är som vår planet står inför. För närvarande fokuserar jag på innovativa metoder som kombinerar olika nya sätt att skaffa inkomst, med utgångspunkt i social rättvisa och naturskydd i **globalt sett kritiska regioner och sektorer**. Kritiska regioner är regioner runt om i världen vars snabba omvandling är särskilt avgörande. Detta beror på att de är uttalat sårbara för globala ohållbara mänskliga handlingar (små ö- och utvecklingsnationer, regioner runt skyddade områden, och kustekosystem för att nämna några) eller på att de har stor inverkan på omvandlingen av globala system (till exempel tropiska regioner) eller särskilda delsystem (såsom turism). Genom åren har jag haft möjlighet att forska i bland annat Kina, Indien, Sydafrika, Thailand, Costa Rica och Brasilien.
